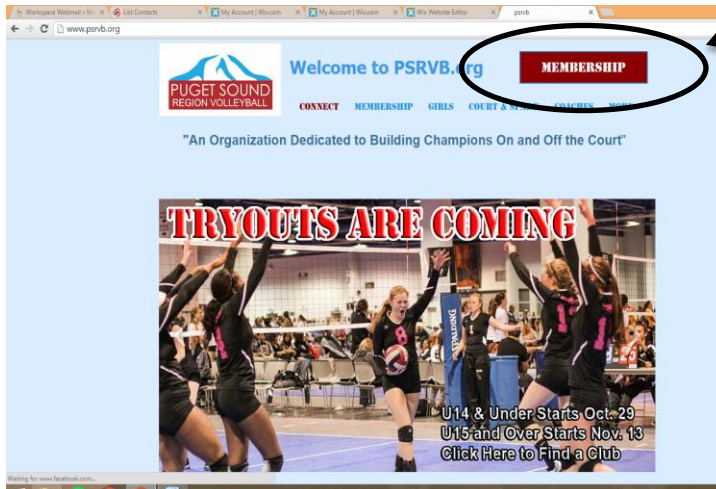


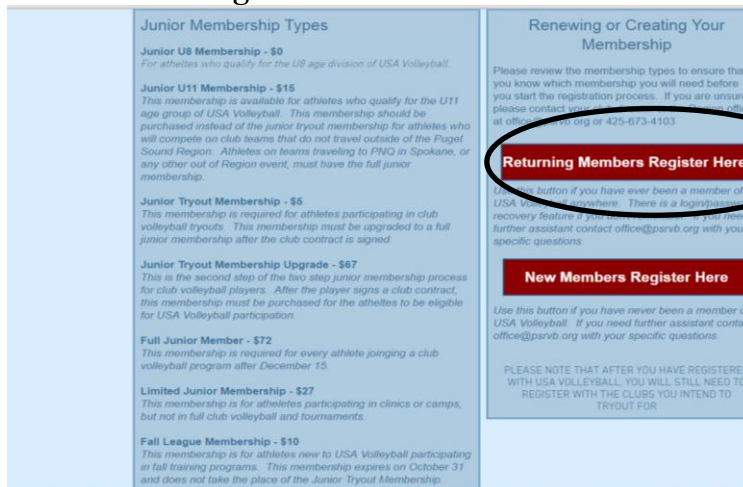

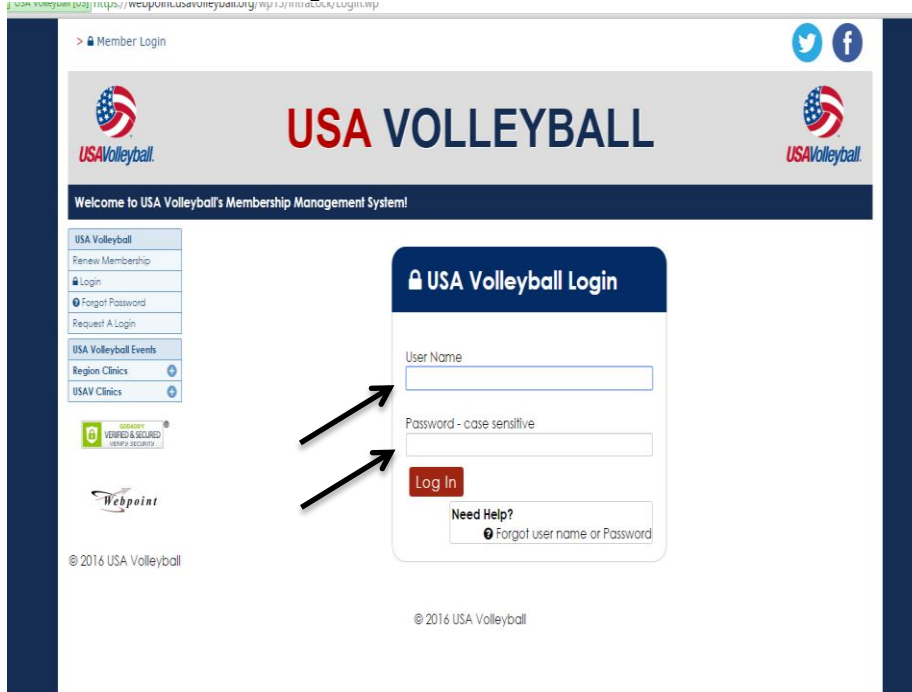
1. Go to the Puget Sound Region Website – www.psrvb.org
